DECLARATION OF CONFORMITY

for bins and containers made from plastic materials
 intended to come into contact with food

Consumer goods and products suitable for direct contact with food, manufactured by BITO-Lagertechnik GmbH and marked with the wine glass and fork symbol, are finished products and reusable articles within the meaning of regulation (EU) No 10/2011. They comply with the provisions set out below in their current version:

- EU 1935 / 2004
- EU 10 / 2011
- EU 2023 / 2006

The raw materials and colour pigments used come with a declaration of conformity from the supplier. Traceability is ensured by the production date shown on the article in conjunction with the article designation. The overall migration as well as the specific migration are below the applicable limit when used according to specification.

Overall migration / Reagents:

The packaging is suitable as reusable packaging for all types of food products.

The packaging is **not** suitable for superheated steam sterilization, microwave use, hot filling.

"Dual-use substances" (substances that are allowed both in foods and in packaging) do not migrate or are contained at such a low level that they have no technological effect in case of migration. They may contain:
